B. **ADVANCE TRAVEL INFORMATION:** U.S. citizens or permanent residents of the U.S. traveling exclusively inside U.S. borders do not need a passport or visa for travel. Homeland Security laws require that all guests travel with government-issued photo identification (ID) (such as a driver's license) at all times. ID must be presented at the time of check-in. AQSC is required to provide all guests' ID information including ID number, expiration date, and place of issue to the Coast Guard and/or other government entities prior to the vessel's departure. Guests must provide this information to AQSC in advance. Travel documents will not be released until received. 

May 7: Arrive in Memphis, Tennessee
