# **Company Audition Information**

Applications are due **Friday**, **January 7 by 11:59 p.m.** If selected for an audition, you will receive a phone call notifying you of your audition time at the James West Alumni Center after we have received and thoroughly reviewed your application. Those who have been selected for an audition will be notified by **Sunday**, **Jan. 9 at 5 p.m.** 

The individual audition will be made up of the following components (subject to change):

- (1 2 minute) Comedic Monologue: You can choose your own or write your own comedic monologue to perform.
- (1 minute) Original Song: Please write a comedic parody of a popular song or rap. You
  may audition with or without musical accompaniment. Impress us with your creativity
  and pop culture/UCLA student relevance. Of course, you will be performing it for us!
- (1-2 minute) Pitch: Pitch an original sketch appropriate for the show.
- (2-3 minutes) to Express Yourself: Use this time to highlight any unique or individual skill you would bring to Company. You can prepare anything and bring in anything you need, or simply say a few words about yourself that you think will be a selling point.
- (1-2 minutes) Short Interview: We will be asking you a few questions to find out a little bit more about you.
- After individual auditions, we will be contacting those of you who have been selected for a callback audition. These callbacks will be group auditions/interviews.



#### PREPARING YOUR SKETCH

- Lists. It's valuable to make a list before writing a sketch so that you can be sure to include the funniest and
  most specific ideas, lines, and references. The first idea is not always the best. Also, lists help you make sure
  your bits are heightening in the correct order. List all the funny things that could happen in the sketch before
  actually sitting down to write it.
- The game should be indicated within the first three to five lines. Cut to the chase; get to the game right away so you can hook the audience in. Don't tease them with the game, spit it at them.
  - Establish who, what, and where as quickly as possible within the first line or two.
  - Sometimes try to start in the middle of the action. This will help jumpstart the scene.
  - Try writing three alternative paths that the scene could go, and then choose the best one.
  - If someone or something is weird, call attention to it, and then explain it. have a line of brilger thablish
  - Rewrite. No sketch is 100% after the first draft.

#### PRESENTING YOUR SKETCH

- The title should not be coy and should be the sketch in four to five words.
- Titles should both explain the game and make the scene sound interesting/funny if the title were written on an index card and placed on a board.
- If your title is "Crazy \_\_\_\_" or "The Inappropriate \_\_\_\_" then your premise is too simple.
- Common ways to end a sketch: A live sketch can end with a link to another. A reversal (twist ending) is another common way to end a sketch.

#### GENERAL NOTES

- Anyone should be able to read the sketch and understand the humor; it can't be based in performance.
- Sketches aren't small stories. It's not an arc; it's a stairway going up. Heighten and explore to the top of the stairs. There is no need for turns or changes of heart like in classic story set ups.
- Give a scene its philosophy. Work as many details into a game as possible; there are more jokes that way.
- A joke needs to heighten because reasons heighten. Apply logic to the scene. Why is this happening?
- Ground scenes in reality. Don't jump to the craziest idea right away. Earn or build to something crazy before you throw it in a sketch. I'm not interested in scenes that take place in "Crazy Town." I only want to watch the development of one crazy idea, not more. Stick logic behind what is written. Justify your trips to "Crazy Town."
